RULES FOR MEMBERS USING THE RIDING AREA

- Riders enter and ride at their own risk
- This facility is for its members and all members have equal rights
- Only members and their guests are allowed to use the facilities
 - A full riding member is only permitted to bring the same guest twice in their lifetime, before the guest is required to become a member
 - Members are responsible for the safety and behaviour of their guests
- Approved safety helmets must be worn at all times whilst riding on the grounds
- Riding boots with a heel must be worn
- Members are required to be courteous to other riders and use common sense when other people are sharing the facilities. It is important for each rider to consider the safety of others.
 - When sharing the arena with other riders you pass left shoulder to left shoulder when on track
 - Slower paces stay to inside of track
- Riders must use designated riding areas only
- Under no circumstances are horses allowed to **run loose** on any part of the property
- Horses are not to be tethered on any parts of the grounds except to designated tie rails
- Loose dogs are not permitted on the grounds
- Any person wishing to instruct on the grounds (who is not a member of IRG) must be approved by the committee and show proof of holding current public liability insurance.
- Please respect members who are having a lesson with a paid instructor and use a different part of the arena if possible.
- Gates to the property must be kept locked at all times
- Ground conditions may change and it is the rider's responsibility to check the conditions of the grounds prior to riding
- The committee reserves the right to amend rules at any time

I have read, understand and will abide by all the rules of the Ingleside Riders Group

- If any person is seen to be abusing or not complying with the rules then the committee can terminate that persons membership
- Members agree not to drink alcohol or take drugs prohibited by law before or whilst using this facility

ABN 34 876 267 725 WAIVER AND INDEMNITY FORM / RISK WARNING

Horse riding is an inherently dangerous and risky activity. I understand and acknowledge that horse riding is a dangerous activity and that horses can act in a sudden and unpredictable (changeable) way, especially if frightened or hurt.

Any person coming onto this land, being Ingleside Equestrian Park, located between Wattle Road and McLean Street, Ingleside, NSW does so at their own risk. Those in control of a horse on Ingleside Equestrian Park are responsible for its actions and loss or damage it may cause to people, their property, other horses or the property of Ingleside Riders Group Inc. The Ingleside Riders Group Inc. which conducts equestrian related activities on Ingleside Equestrian Park is not responsible to any person for any loss or damage caused to them, any child in their care or any animal owned by them or under their control, as a consequence of handling or riding a horse or the actions of a horse.

Waiver

By you signing this form, you waive whatever rights you may have against the Ingleside Riders Group Inc. and the signed form is intended to prevent the Ingleside Riders Group Inc. being liable to you for any accident, loss or damage (in this document called "loss") incurred or suffered on the property known as Ingleside Equestrian Park, leased by the Ingleside Riders Group Inc. from the Department of Education ("the property") by you or any horse in your control in any of the circumstances set out in this form.

Indemnity

It is also intended that if the Ingleside Riders Group Inc., for any reason becomes liable for loss suffered or incurred in any of the circumstances listed below, then by signing this form, you indemnify Ingleside Riders Group Inc. for any such loss and you will be liable to pay to or reimburse Ingleside Riders Group Inc. for the amount of any such loss incurred.

The following is a list of circumstances covered by this waiver and indemnity, either singularly or in any combination and should not be construed as an exhaustive list

Any loss to you or your child or any member of your family or any person invited by you or your child onto the property arising out of:

- (a) The negligence or neglect or actions or failure to act by any other person including an instructor.
- (b) Any accident
- (c) Any theft on the property.
- (d) Anything you do or fail to do
- (e) Any action of your horse or a horse in your control or care, or a horse owned or in the care or control of another person.

I understand and acknowledge that serious **INJURY** or **DEATH** may result from horse riding activities and in particular this venue. I agree that **I RIDE** at my **OWN RISK**.
